

# Post Payment Claim Recoupments may be reversed

Idaho Department of Health Welfare is allowing for Technically denied cases in which payment recoupments have occurred to be reopened and reviewed.

\*\*This is only for cases that were technically denied due to not submitting requested medical records timely. This is NOT for cases that were clinically denied or denied due to a billing error.

Telligen will begin reopening and reviewing technically denied cases in October. This will be done in six phases.

- Hospitals will be notified via email and mail to submit a list to Telligen of the claims that have been recouped. At that time, specific instructions of the process will be given.
- Please do not submit records or claim lists until you receive directions to do so.
